Anne and her family in the annex of his spice factory in Holland. My family has a history of standing up and doing what is right in the face of injustice.

I understand this class was taught by a teacher with more than 20 years of experience. Why doesn't the school board trust the experienced teacher to teach the class professionally and use some tact to discuss the difficult material?

A further policy, GKB po2240 Controversial

states as follows, and I'm quoting here: "The school board believes that the consid-

eration of controversial issues has a legitimate place in the instructional program of the School District. Properly introduced and conducted, the

consideration of such issues can help students learn to identify important issues, explore fully and fairly all sides of an issue, weigh carefully the values and factors involved, and develop techniques for formulating and evaluating positions.'

I have read the board policy and the timeframe is such that the policy could not have been followed. It also lacked transparency. I find that troubling. It seems the superintendent granted himself administrative

As an attorney, I feel you did not consult your legal counsel in this matter.

This leadership response was very reactive to the complaint of one parent rather than the thoughtful, considered and proactive approach striving for what is best for all students.

The board did not follow established procedure and abrogated the primary duty, which is education, in a kneejerk reaction to a single complaint.

This is not about, "I want the book" or, "I don't want the book. Established procedures were not followed. This was about a lack of transparency and an abuse of power. Clearly, legal counsel had not been consulted. Concerned parents and citizens need to demand accountability.
